

Think and Choose Renewable: Tree Vital Pursuit Prize Draw Terms and Conditions

Prize Draw Overview

1. The Promoter is running a series of prize draws (each a **Prize Draw**). Each Prize Draw will be treated as a separate prize promotion and one winner will be selected for each Prize Draw.
2. By entering this promotion, all participants will be deemed to have accepted and be bound by these terms and conditions (the **Terms**). Promotional materials relating to the Prize Draw, including all information on how to enter, also form part of these Terms. In the event of any conflict between any terms referred to in such promotional materials and these Terms, these Terms take precedence.
3. The Prize Draw is open to residents of the United Kingdom only, except employees of the Promoter, WWF-UK, Stream Limited, Fishburn Hedges and their children and any other person, and their children, involved in or connected with the operation or fulfilment of this promotion.
4. If you are:
 - **under 12 years old, your parent or legal guardian must explicitly consent on your behalf to you (and supervise you) entering the Prize Draw on the basis of all of these Terms;**
 - **between 12 and 16 years old you confirm that you have read, understand and agree to these Terms; if you are in any doubt as to the meaning of any of these Terms please ask your parent or legal guardian to explain and ensure that they consent to your use of this website and entry to the Prize Draw.**
5. The Promoter reserves the right (in its absolute discretion) to refuse entry and/or disqualify any person under the age of 16 years, which it believes does not have the requisite consents or does not fully understand any of these Terms (including the publication of its personal data on the internet).

Entry to the Prize Draw and Selection of the Winner

6. The starting date for entry to the first Prize Draw is **18 May 2011** and the starting date for each subsequent Prize Draw shall be the commencement of each two week period thereafter. The closing date for each Prize Draw shall be 23:59 at the end of each two week period, except in respect of the final Prize Draw, which shall close at 23:59 on **29 November 2011** and entries received after this time will not be entered into the final Prize Draw.
7. To enter the Prize Draw, you must either:
 - (a) complete and submit the online registration at www.renewableidea.co.uk (the **Website**) (if you have not already done so) and correctly answer the Tree Vital Pursuit Quiz question set out on the Website (such question may change during the Prize Draw period); or
 - (b) complete an official entry form at an event hosted by the Promoter or any of its affiliated organisations (including schools who are running renewable promotions) and correctly answer the Tree Vital Pursuit Quiz question set out on the entry form.
8. Entry is limited to one quiz per person per day and any multiple entries will be discounted. Entries shall be eligible for one Prize Draw only and will not be carried forward into the next Prize Draw.
9. The Prize Draw shall be held within 48 hours of the closing date for entry to the Prize Draw. The winner of the Prize Draw will be the first name drawn at random from all valid entries received by the closing date under the supervision of an independent observer.
10. The winner of the Prize Draw will receive the prize promoted, on the Website and at any official event, for that corresponding Prize Draw (the **Prize**). The prize applicable to a Prize Draw may differ across the course of the promotion. Any Prize provided by a third party will be subject to the terms and conditions imposed by such third party.
11. The winner will be notified by email (using the details provided at the time of entry) within 72 hours of the draw. Following such notification, the winner shall have 21 days in which to send the Promoter details of their name, age, country of residence and full postal address for delivery of the Prize. In the case of participants under 16 years old, the Promoter may also require a parent or legal guardian to consent to participation by the winner in the Prize Draw on these Terms including consent (i) to disclosure of the delivery address for the Prize; (ii) to publication of the winner's name and county on this Website; and (iii) for the winner to participate in publicity.

12. In the event of failure to provide any of the details or consents (where applicable) detailed in paragraph 11 within the specified time period or in the event that the Promoter cannot contact the winner directly (via the email address provided at entry) within 21 days of the Prize Draw taking place, the Promoter reserves the right to re-draw a winner of the Prize Draw (under the supervision of an independent observer) and thereafter until a winner on these Terms is found.
13. The Promoter (or its partners and/or agents) shall send the Prize to the confirmed winner within 14 days of such winner providing to the Promoter details of their name, age, country of residence, postal address and all required consents.

General

14. The results of the Prize Draw are final and no correspondence will be entered into. No mechanically reproduced entries, entries sent through third parties or through agents are permitted and such entries will not be entered into a Prize Draw.
15. Incomplete entries or those not in accordance with the entry instructions or these Terms are invalid.
16. The Promoter reserves the right to disqualify without notice any entries which the Promoter believes are fraudulent and the Promoter does not accept responsibility for any entries which are incomplete, lost, delayed or not received for whatever reason.
17. The Prize is non-transferable, subject to availability and no cash alternative is available. In the event of circumstances outside of its control, the Promoter reserves the right to award an alternative prize similar in quality and value.
18. Details (including the name and county) of the winner will be posted on the Website within 14 days of the winner being confirmed. The winner may be required to participate in publicity arising from award of the Prize and by entering the Prize Draw you agree and provide consent to take part in such publicity. **Please note that, if you are:**
 - **under 12 years old, your parent or legal guardian must explicitly consent on your behalf (at the time of entry to the Prize Draw) to publication of your personal information on the internet in the event that you win the Prize and must agree to accompany you to any publicity events;**
 - **between 12 and 16 years old, you are agreeing to participate in such publicity and publication of your personal information on the internet in the event that you win the Prize. If you are in any doubt as to the implications of providing such consent please ask your parent or legal guardian to explain and ensure that they consent to your entry to the Prize Draw on the basis of these Terms.**
19. To the extent permitted by law, the Promoter shall have no liability for: (a) technical problems of any kind which may limit or prevent participation in the Prize Draw or may result in any entry being lost or not properly received; (b) any damage to, or viruses that may be transmitted to or infect, your computer equipment as a result of your access to the Website; (c) any loss or damage arising from or in connection with the use or allocation of the Prize; or (d) any other events beyond the Promoter's control that may cause the Prize Draw to be disrupted or corrupted or may lead to loss, delay or damage of the Prize in transit to the recipient.
20. The Promoter may amend these Terms, without notice, by posting changes to them on the Website. The Promoter reserves the right at any time, without liability, to cancel, alter or modify the Prize Draw without notice for any reason which falls outside its control.
21. Personal information relating to participants and, where applicable, their parents and/or legal guardians shall only be shared with the Promoter's partners, agents and suppliers to the extent necessary for administration of the Prize Draw and allocation of the Prize.
22. By entering the Prize Draw you consent, if you are 12 years old or older, to receiving email messages from the Promoter in order to provide you with information in respect of the Promoter's other recycling and renewable activities.
